Third Cemetery

Judy Lambert One of the people buried in the Third Cemetery had become famous even before the plague saw him quarantined at North Head.

Thomas Dudley is a person recognised by law students whose training is based on English law. We can thank University of NSW Law Professor Prue Vines for bringing this to our attention when she visited our education room at North Head on a recent rainy afternoon.

The Queen v. Dudley and Stephens was a trial heard before the criminal courts of Devon and Cornwall in November 1884. The case is famous because it defined the place of "necessity" in the killing of another person.

Thomas Dudley, his fellow seaman Edward Stephens, another man named Brooks and a teenage cabin boy Richard Parker were sailing an English yacht to Australia when they were shipwrecked in a storm 1600 miles off the Cape of Good Hope. They took to a small open boat, but had few supplies. After 7 days without food and 5 days without water Dudley and Stephens decided that the boy, who was by then the weakest among them, should be killed and eaten.

Four days later their open boat was picked up by a passing vessel and taken to the port of Falmouth, and then to trial in Exeter. During the trial it was argued that at the time of the killing they had no prospect of rescue and that had they not killed and fed upon the body of Parker they would have died of famine.

The case was adjourned on two occasions, but finally a hearing by a High Court of five Judges ruled that they were guilty of murder. The Judges determined that where a private person acting upon his own judgment takes the life of another, his act can only be justified on the grounds of self-defence. A case was put by their defence that they had acted out of necessity and should not be found guilty of murder.

After considering a number of case precedents, Chief Justice Lord Coleridge and his fellow Judges ruled unanimously that "the prisoners' act in this case was wilful murder, that the facts as stated in the verdict are no legal justification of the homicide" and that the prisoners were guilty of murder.

Dudley and Stephens were sentenced to death, but their sentence was later commuted on compassionate grounds, to six months imprisonment.

Not only is this a case famous for the legal precedent set. It is also the basis upon which the

Monty Python Shipwreck cannibalism sketch is based.
